What is OASIS?

One Acquisition Solution for Integrated Services (OASIS) is a General Services Administration (GSA) Best-in-Class vehicle that provides clients across the Federal Government with easy access to complex professional services. The OASIS program provides access to pre-qualified awardees of two separate contracts: OASIS Unrestricted, and OASIS Small Business (SB). GSA awarded Palmetto GBA the OASIS Unrestricted contract for Pool 2 (Financial Services) in September 2019.

What Are OASIS Benefits?

- Multiple-award, IDIQ contracts available for government-wide use
- Multidisciplinary government-wide contract for professional/integrated services
- Single solution for complex requirements
- Multiple technical areas/mission spaces
- Maximum flexibility for ancillary support

Getting Started with OASIS

- 1. Delegation of Procurement Authority (DPA) is required to issue an order on OASIS.
- 2. Determine the OASIS principal-purpose NAICS code of your requirement.
- 3. Determine if setting aside to small business.
- 4. Build the solicitation using FAR 16.505 ordering procedures.
- 5. Issue solicitation under the determined pool.
- 6. Receive the offers.
- 7. Evaluate offers and make award.
